VIII. Description of my major research topics.

I have a lasting scholarly interest in the relation between art and politics and I am researching various aspects of cultural and political opposition. This interest translates with the focus on modernism and avant-garde and underground as far as cultural opposition is concerned and with the focus on dissident movements in politics. I am also interested in moments and personalities where both aspects meet, such as the aesthetic thinking of the Czech philosopher Jan Patočka. Most lately, I have published extensively on the comparative history of the avant-garde and the complex relation between aesthetics and political practice. My current research project in collaboration with the University of Oxford and funded by Fondation Wiener Anspach (2022-2024) “When Rural Meets Urban: Towards a Cultural History of Central European Modernisms” will allow me to explore the sociocultural aspects of modernisms in Bohemia in the beginning of the 20th century. As a member of the editorial board of the ambitious project *Cultural History of Central-European Avant-Gardes* I am currently contributing to the re-evaluation of the contribution of Central European Artists to the general history of the Avant-Gardes. My current interest in the cultural and political dissent could be traced back to this original research topic. I have been publishing on literary representations of Cultural Memory in contemporary Central European fiction. I draw on methodology coming from Cultural Memory Studies and Trauma Studies and collaborate with experts in the field on several research projects. In my research focused more exclusively on the study of aesthetics I explore the origins and specificities of Central European modernisms and the avant-garde, a topic naturally stemming from the scholarly expertise acquired in my previous research.
